Lead managers for this issue will be Citigroup, HSBC, and Nomura. Seven co-managers and a distribution group will complete the syndication team.

At this time, the new issue is expected to be priced tomorrow, July 13, 2016. The CUSIP of this issue will be 3130A8QS5. Interest payments will be made semi-annually on July 14 and January 14, beginning January 14, 2017, and the bond will mature on July 14, 2021.
