FHLBanks Price SOFR-Linked Bonds

The Office of Finance announced today that the Federal Home Loan Banks (FHLBanks) have priced a set of bonds linked to the Secured Overnight Financing Rate (SOFR), their first in 2019.

SOFR, identified by the Federal Reserve's Alternative Reference Rates Committee (ARRC) as its recommended alternative to U.S. Dollar LIBOR, has been published since April 2018. The FHLBanks issued their first SOFR-linked bonds in November 2018.

"Today's offerings further demonstrate the Federal Home Loan Bank System's commitment to continued participation in this developing market as investor appetite for SOFR-linked debt grows," stated Randy Snook, CEO of the Office of Finance since January 1, 2019. "The eleven FHLBanks are prepared to continue to support their nearly 7,000 members of all sizes as a valuable source of liquidity during this transition away from LIBOR."

Today's SOFR offerings were led by Citigroup Global Markets Inc., Jefferies LLC and Nomura Securities International, Inc., with CastleOak Securities, L.P. and MFR Securities, Inc. acting as co-managers. The two-tranche \$2.75 billion transaction is scheduled to settle on January 17, 2019.
